The National Childcare Scheme (NCS) is a government program designed to provide financial support to families for childcare costs and early learning.

Since 2019, all families have had the opportunity to apply for the National Childcare Scheme, offering them a discount off their weekly bills.

Fach child will be entitled to receive a minimum of €2.14 per hour from September/24 deducted from their childcare bill (this is a non-means-tested rate) and up to €3.75 per hour (a means-tested rate).

We provide dynamic and enriching environments where children can flourish, engaging in activities that extend beyond the school curriculum.

As only available for a Tusla registered services, the National Childcare Scheme ensures that even more families can access high-quality childcare at an affordable price.

Make a booking enquiry through our Registration Form

- 1. Contact the relevant Sherpa Kids service who will advise you about our registration process.
- 2.Complete our online Enquiry Form via the following link

- 3. Thereafter the Sherpa Kids Registration Form will be emailed to you so that you can provide details such as your name, your child/ren details, services required (before, after school and/or holidays programmes), dates, emergency contact details etc.
- 4. Submit your completed Registration Form via email to the contact person at your chosen Sherpa Kids service who will send the booking confirmation (subject to availability).

Check your eligibility and calculate your NCS subsidy

Starting your NCS Application

To start your NCS application you will need your MyGovID account on hand.

Your MyGovID Account: If you do not have a MyGovdID account or you do not have access to this - you will need to create and/or verify your account via the government website: https://www.mygovid.ie/.

For this, you will need:

- Your PPS (Personal Public Service) number
- Your Public Services Card
- Your mobile phone

Complete the NCS Application & send it to Sherpa Kids

After verifying your MyGovdID account, make sure you have the following details for each child you are applying for:

- Date of Birth
- Personal Public Service Number (PPSN)

Receive your CHICK Code: If you are eligible for the NCS subsidy and your application has been processed, you will be notified by the amount you are eligible for and receive a unique "CHICK CODE" on the HIVE portal.

Once you have received confirmation of this, please send a screenshot of your valid CHICK CODE to kinsaleaccounts@sherpakids.ie. Please note that this screenshot should include all your child's details. This should be done at least 1 week before the service commences to ensure subsidised fees.

Confirmation of your Subsidy

Any NCS subsidy will automatically be deducted from your bill each week and your invoice will be sent to you with your full statement breakdown.
